Limited Warranty Information For The United States And Canada

New, serialized product

EnGenius Technologies, Inc. warrants new and serialized EnGenius branded hardware product against defects in materials and workmanship under normal use for the Warranty Period, which begins on the date of purchase by the original end-user purchaser and lasts for the period of One (1) Year. This limited warranty is non-transferable and extends only to the original end-user purchaser. Your exclusive remedy and EnGenius Technologies' entire liability under this limited warranty will be for EnGenius Technologies, at its sole option, to (a) repair the product with new or refurbished parts or (b) replace the product with a reasonably available equivalent new or refurbished EnGenius Technologies product. Any repaired or replacement products will be warranted for the remainder of the original Warranty Period or Ninety (90) days after receipt of the repaired or replacement product(s), whichever is longer. All products and parts that are replaced become the property of EnGenius Technologies.

New, non-serialized product

Refurbished, serialized product

Firmware / Software
