EnGenius Cloud Five-Year Limited Hardware Warranty Terms

The following are terms applicable to your EnGenius Cloud hardware limited warranty. The EnGenius Cloud part number prefixes include ESG, ECW, ECS, ECP, and EXT. The 5-year hardware limited warranty applies retroactively from January 1st, 2024. Your embedded software is subject to the EnGenius Technologies EULA.

Duration of Hardware Warranty

Five (5) Years, except for EnGenius Cloud outdoor products (e.g. ECW160, ECW260, and ECW270), the warranty period is two (2) Years. EnGenius Telecom and Fit Series come with a limited warranty of one (1) year.

Replacement, Repair or Refund Procedure for Hardware

EnGenius Technologies, Inc. will use commercially reasonable efforts to ship a replacement part within ten (10) working days after receipt of the RMA request. Actual delivery times may vary depending on Customer location.

Limited Hardware Warranty

EnGenius Technologies, Inc., selling the Product ("EnGenius Cloud") warrants that commencing from the date of invoice to Customer (and in case of resale by a EnGenius Technologies reseller, commencing not more than ninety (90) days after original invoice by EnGenius Technologies), and continuing for a period of the longer of (a) ninety (90) days or (b) as otherwise set forth at (<https://www.engeniustech.com/five-year-warranty.html>), the Hardware will be free from defects in material and workmanship under normal use. The date of invoice of a Product by EnGenius Technologies is set forth on the invoice in which the Product is invoiced. This limited warranty extends only to the original user of the Product. Customer's sole and exclusive remedy and the entire liability of EnGenius Technologies and its suppliers under this limited warranty will be, at EnGenius Technologies, shipment of a replacement within the warranty period and according to the replacement process as described on the EnGenius Technologies Product Warranties web page (<https://www.engeniustech.com/five-year-warranty.html>) EnGenius Technologies replacement parts used in Hardware replacement may be new or equivalent to new. EnGenius Technologies' obligations hereunder are conditioned upon the return of affected Hardware in accordance with EnGenius Technologies' then-current Return Material Authorization (RMA) procedures.

Restrictions

This limited warranty does not apply if the Hardware (a) has been altered, except by EnGenius Technologies or its authorized representative, (b) has not been installed, operated, repaired, or maintained in accordance with instructions supplied by EnGenius Technologies, (c) has been subjected to abnormal physical or electrical stress, abnormal environmental conditions, misuse, negligence, or accident; or (d) is licensed for beta, evaluation, testing or demonstration purposes.

Nothing in this limited warranty limits or excludes any liability that cannot be limited or excluded under applicable law.
